

## American Sign Language Interpreters

The University has contracted with five (5) Contractors for all American Sign Language Interpreting Services - University Wide. The award of Proposal #P09-087 is effective April 1, 2010 through March 31, 2013, and may be extended two additional years at the discretion of the University.

The requisitioner will request a quote from one or more of the listed Contractors to provide the services needed. The department representative will select a Contractor according to proximity and availability of the Contractor. After making a selection, the requisitioner will submit the requisition to Purchasing Services for processing. A Purchase Order will be issued in the amount of the quotation to the Contractor selected. Remember, when submitting an Electronic Requisition through MarketPlace, to attach the quote.
