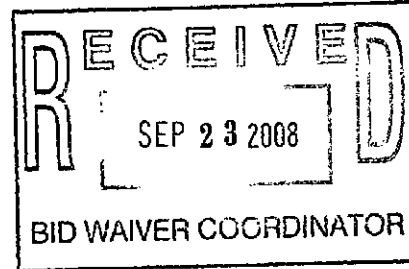

## CONTRACT AMENDMENT 4

This is the fourth amendment ("Fourth Amendment") to the contract effective the \_\_\_\_ day of \_\_\_\_\_, 2008, (hereinafter "Agreement") by and between Adecco USA, Inc. (hereinafter "Vendor") and the University of Medicine and Dentistry of New Jersey (hereinafter "University"), resulting from RFP #P06-012 and Vendor's response of November 10, 2005.

WHEREAS, pursuant to the Agreement, Vendor provides On-site Temporary Staffing and Pre-employment Testing Services for the North and Central Jersey Campuses of the University; and

WHEREAS, Section 3.1.1 of the Agreement requires all Subcontractors to furnish a Joint Commission Accreditation for Hospital Organizations' Compliance Certificate

WHEREAS, the University and Vendor wish to clarify the JCAHO Compliance Certification requirements as they relate to areas of the University that are not governed by JCAHO guidelines;

WHEREAS, the University and Vendor wish to add/and or change specific terms set forth in the Agreement;

NOW THEREFORE, in consideration of the mutual covenants herein, the parties agree as follows:

1. Contractor including any Subcontractors providing staffing services to any areas of the University that are not subject to the Joint Commission Accreditation for Hospital Organizations' ("JCAHO") jurisdiction will not be required to furnish to University a JCAHO Compliance Certificate. University shall determine if JCAHO Compliance Certificate is required on the requisition order.
2. Any order requiring rate categories, skills, job titles and/or job classifications other than those referenced in the Agreement ("Exception Orders") shall be confirmed by University by email. Such email confirmation shall be deemed to be conclusive evidence of the parties' agreement as to any such Exception Order, shall be deemed to be added to the Agreement, and no written agreement or amendment shall be required.
3. The provisions of the Agreement not specifically addressed herein shall remain in full force and effect as they appear in the Agreement, as amended.
