

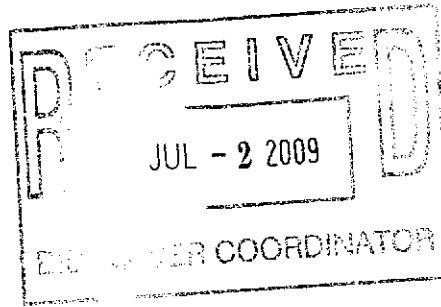

FIRST AMENDMENT

THIS FIRST AMENDMENT to the Document Destruction Service Agreement, made this ____ day of June 2009, by and between Shred-it USA, Inc., having its principal place of business at 81 Walsh Drive, Parsippany, New Jersey 07054 (hereinafter "Vendor") and the University of Medicine and Dentistry of New Jersey, having its principal place of business at 65 Bergen Street, Newark, New Jersey 07107 (hereinafter "UMDNJ").

WHEREAS, the Vendor entered into a contract with UMDNJ to provide a document destruction services for UMDNJ, the same which has been in effect since October 15, 2008.

WHEREAS, the parties desire to amend the Document Destruction Service Agreement as provided herein.

NOW THEREFORE, in consideration of the terms and conditions contained herein, the parties agree as follows:

1. Commencing October 15, 2009, Section 3 of the Agreement ("Fee") shall be supplemented with section 3(E) in which UMDNJ agrees to pay the Vendor five dollars (\$5.00) per carton or box for retrieving the document contents from cartons or boxes located at UMDNJ campus or affiliate sites and destroying the documents contained therein at the Vendor's secured, Parsippany, New Jersey facility.
2. Except as provided herein, the balance of the Document Destruction Service Agreement remains unmodified and in full force and effect.
